

## JMEIT RESEARCH EXCELLENCE AWARD-2017

### Instructions to the applicant

1. JMEIT is pleased to announce that the nomination for JMEIT Research Excellence Awards -2017 is now open.
2. The last date for sending complete application is **28 Feb 2018**
3. The results of JMEIT Research Excellence Awards -2017 will be announced by **15 Apr 2018 online** on Journal website [www.jmeit.com](http://www.jmeit.com) winners will be communicated personally via e-mail.
4. The JMEIT Research Excellence Awards -2017 winner will be recognized by giving INR 1500 in which there will be a cheque of INR 1000 and a discount coupon of INR 500 to be redeemed at JMEIT for having the discount in publication fee for the research article. The discount coupon can be redeemed any time in the year 2018 by the winner in the forthcoming issues of JMEIT. Furthermore, there will be a certificate, medal, batch and a memento/shield mentioning the details of the winning award to be dispatched to the winner. Furthermore, there will be an appreciation certificate to all those who had contributed significantly well in the field of research, but do not win any award.
5. The applicant should be an Indian Citizen.
6. The applicant should be a permanent and regular faculty in an education institute recognized by UGC/ AICTE.
7. The applicant should be in service on continuous basis from last 3 years at least to apply.
8. The applicant should forward the application from proper channel to avoid any turbulence in future.
9. The applicant should note that each application must be endorsed by HOD / faculty members. Endorsements can be obtained from any Faculty; however, faculty members may not endorse more than one application in each category. The applicant is suggested to find the format at the end of the application form.
10. The applicant should keep all the records handy in a soft copy [self-attested] so that as and when asked the applicant can send us for further processing.
11. The applicant can apply in more than one category of JMEIT RESEARCH EXCELLENCE AWARD, if he/ she is eligible. In this case there has to be a separate application with category of awards mention clearly.
12. The applicant should be from the streams – Engineering, Management and Information Technology/ Computer Science.
13. Approval or disapproval of any application will be wholly and solely the decision of the Jury. The judgment of the jury will be final in all means, no further communication is entertained in any case.
14. In the case of “students category” the application should accompanied with an affiliation certificate duly signed and stamped by competent authority. The applicant is suggested to find the format at the end of the application form.
15. The applicant should note that there are different category mentioned for the JMEIT RESEARCH EXCELLENCE AWARD, he/ she should be very clear to apply within the category. After submitting the application there is no scope of change as we have to do lot of background task and it is next to impossible to manage things in proper way.
16. All the communication will be “online” though an email – id “[jmeitresearchexcellenceawards@gmail.com](mailto:jmeitresearchexcellenceawards@gmail.com)” only.
17. The applicant should note that this application is only for the year 2017 only. Kindly submit the updated records for the year 2017 only.
18. Kindly note that each and every application is allotted with unique application id that will be communicated through mail. The applicant should mention this for any future communication.
19. The application should be filled appropriately with accuracy. Only fully completed application form will be considered valid. Incomplete application form provided by you will tend to rejection.
20. If the applicant fails to produce the required and relevant documents to prove the eligibility for the JMEIT- Research Excellence Awards thus tends to automatic rejection of the application. In the case the award winner who fails to produce documents in support of the claim, the next runner up will be declared the winner instead of the applicant.
21. The applicant should strictly follow all the rules and regulation provided by JMEIT- Research Excellence Awards.
22. The applicant should note that he/ she has to give a write-up in 150 – 250 word count mentioning the need of research and his/ her major contribution of research towards the need. This must reflect the need full filled by research work in the year 2017 in the space provide in the application form.
23. Kindly note that to promote the research work for the beneficiary to the masses the applicant’s details like mail id can be used by the JMEIT for the promotional offers.
24. Applicant kindly note that there is a participation fee for the JMEIT RESEARCH EXCELLENCE AWARD, for Faculty it is INR 1100/- and for the students [covers U.G., P.G. and Scholars] it is 800/- + INTER BANK CHARGES [75/-].
25. Kindly note that any members of JMEIT associated directly or indirectly cannot apply/participate in the award process.
